Parent Consumables

SERVICES

1. Student must meet **General Eligibility** requirements.
2. Fill out a Request for Services form (available from **P.I.T.U. Education Dept.** **Aug. 1-Sept. 30th** of each school year) and turn in *with original purchase receipts.*
3. Reimbursement amount will not exceed \$ **50.00 per eligible student.**

General Eligibility

1. Must be at least 3 years of age before August 31st of each school year and no older than 12th grade and enrolled in school.
2. Enrolled member of the Paiute Tribe of Utah.
3. Live within Washington, Iron, Millard, & Sevier counties.
4. Sign a release of education information to the Paiute Tribe education department.
5. For some services you must meet an income eligibility guideline. (Information on request).

Eligible Items such as include, but are not limited to:

1. School Supplies (tablets, paper, pencils, markers, etc.)
2. Shop Supplies (wood, tools)
3. Instrument Rental (band or music)
4. Home Economic Lab Fees (sewing materials, etc.)
5. Lab Fees (Science, Math)
6. P.E. (Gym uniforms)
7. Test Fees (ACT, etc.)
8. Extra-curricular Supplies (Native American Club, Drama, Speech)
9. Sports Activities (gym shoes, uniforms, sports fees)
10. Science/environmental Projects (materials)

Unallowable costs are items that are not required for school participation.

1. Graduation Announcements
2. Class Rings
3. Personal Clothing
4. Letter Jackets
5. Class Pictures
6. Class yearbooks (Annuals)
7. Livestock
