

INSTRUCTIONS FOR TRIBAL CHAIRPERSON ELECTION

The “Tribal Chairperson Election” will be conducted on **Thursday, June 15, 2017**, between the hours of **11:00 AM - 7:00 PM**, at the Tribal Building in Cedar City, Kanosh Band Building, Shivwits Band Building, and Koosharem Band Building.

ABSENTEE BALLOTS have been mailed to ALL TRIBAL MEMBERS with a current known address outside of the four county area (Iron, Millard, Sevier and Washington) and will be available for others by request.

The following instructions apply to all absentee voters:

“A ballot listing the name(s) of candidates, this instruction sheet, application for absentee ballot, a smaller envelope (mark ballot), and a stamped self-addressed return envelope is included.

The voter shall mark the ballot and place it in the smaller envelope marked “ballot” and then seal the small envelope and return it with the signed absentee application in the addressed return stamped envelope. **THE ABSENTEE BALLOT MUST BE RETURNED IN THE SELF-ADDRESSED ENVELOPE THAT IS PROVIDED. IF NOT, THE BALLOT WILL BE AN INVALID BALLOT AND THE VOTE WILL NOT BE COUNTED.**

BE SURE AND RETURN ABSENTEE BALLOT IMMEDIATELY. **ANY ABSENTEE BALLOT RECEIVED AFTER 7:00 PM, June 14, 2017 WILL NOT BE COUNTED.**”

Please mail these back - there will be NO walk-in absentee ballots ACCEPTED on the election date.

The candidate who receives the HIGHEST number of votes will be declared elected as Tribal Chairperson of The Paiute Indian Tribe of Utah and as a Tribal Council Member. In the event of a TIE, a flip of a coin as overseen by the Election Board shall determine the winner.

Any member whose name appears on the membership roll and who is 18 years of age or older on the day on the election is entitled and eligible to vote.
